Project Title	European Data on Sport and Physical Activity	
Project Outline	<p>The overall objective of this project is to increase the availability and quality of European sport related evidence and data at regional and national level. The goal is to define and develop a set of shared indicators which will be measured by the participating European regions and member states, and then gathered in a shared web platform. This project will serve as a pilot which will then be opened to the participation of all European regions and member states.</p> <p>Thus, through this project we wish to create a web-based service platform, aiming at gathering, on a regular basis, data on a series of shared indicators related to different sport areas (such as sports activity, existing sport facilities and infrastructures, sport related human resources, training and capacity building, sports economic aspects etc.) with the objective of getting to know and following up the evolution of those indicators.</p> <p>This project would allow public authorities, private entities and other interested stakeholders to know the state of the art of sports at regional and member state level and to analyze and compare data at regional, member state and European level.</p>	

	<p>Ultimately, this project would help public authorities to develop sport related policies based on high quality objective evidence and data, thus enhancing good governance.</p> <p>The need for this project derives from different factors:</p> <ul style="list-style-type: none"> - Nowadays, in the sports' field, there isn't at European level a project of similar characteristics apart from the relatively scarce data offered by the Sport Eurobarometer, and in this case, data is provided at country level. - Most European regions and member states carry out studies and data collection on physical activity and sport on an ad-hoc basis, without a shared methodology and indicators. - For public authorities it is very difficult to develop good quality sport policies and initiatives as there is a general lack of evidence and data at European level.
Activities	<p>So far we have identified the following activities:</p> <ul style="list-style-type: none"> - Create a network of regions and member states which will part of the project during the pilot phase - Establish a "scientific committee" which will define the list of shared indicators as well as the methodology to be used to measure those indicators - Develop a web platform in which to upload the data - Gather the data from partner regions and member states and from secondary sources - Upload data on the platform and drafting a comparative report - Design a methodology to expand the network to other European regions and member states
